Terms and Conditions

- The primary objective of the Ramsdell Village Hall Lottery ("the Lottery") is to raise funds for the New Ramsdell Village Hall ("RVH"), which is a registered charity CIO 1177240. A proportion of the proceeds may be donated to other charitable causes from time to time as determined by the Trustees.
- The second objective of the Lottery is to provide participants with the chance to win cash prizes.
- The Lottery will be run under the supervision of the Trustees of RVH. The Lottery is designated a 'Small Society Lottery' in accordance with the Gambling Act 2005, registered with Basingstoke and Deane Borough Council no. 22/00399/LOTREN.
- The Lottery is open to residents of Ramsdell and Charter Alley and neighbouring villages, and anyone else having an association with the villages.
- New participants may join the Lottery at any time after its launch.
- A Registration Form must be completed for each prospective participant to be registered as a Member.
- Members must be 16 or over.
- Depending on their payment preference Members must:
 - Make an upfront annual payment of £60 per ticket by bank transfer or cheque; or
 - Arrange a Standing Order to pay £5 per month per ticket for a minimum period of 12 months
- In all cases payments are to be made to the Ramsdell Church & Village Hall bank account.
- Gift Aid cannot be claimed by RVH for Members' payments, because HMRC regulations deem such payments as purchasing a right to enter a lottery and not as a donation/gift.
- Members may have one or two tickets registered in their name. No more than 10 tickets per household are permitted.
- Unless otherwise advised, a Member will be deemed to have left the Lottery if their annual or monthly subscription remains unpaid for more than two months.
- All active Members' tickets will be entered into every month's draw, even if they have won before.
- A draw is held on the fourth Friday of each month. Only the tickets of Members whose standing order payments have been received by the second Friday of the month, or have pre-paid annually, will be entered for that month's draw.
- The quantity of winning ticket numbers drawn and the value of the prizes depends on how many tickets have been purchased.
- The target monthly prize fund is 25% of the monthly income from ticket subscriptions. This will be adjusted as the quantity of tickets in each draw changes:

Tickets in Draw	50	100	200	300
Monthly Prize Every Month	£50	£50	£75	£100
Quarterly Prize January/April/July/October	-	£100	£250	£500
Additional Christmas Prizes November	£150	£500	3x £100 1x £750	3x £100 1x £1000

- Winners will be contacted personally and will be announced on social media and the RVH website unless a Member ends a request in writing to the Lottery Administrator to withhold their name.
- Members are obliged to inform the Lottery Administrator of any changes to their contact details.
- If a winner cannot be contacted, their winnings will be donated to the RVH funds after three months.
- The name, email address, postal address and phone number of each Member will be held securely on a computer, along with the ticket number(s) allocated to them and the subscription payments received from them. A Member may request a copy of their information from the Lottery Administrator.
- If the quantity of active Members reduces to the level that renders the Lottery unsustainable, it may be discontinued with 6 months' notice given to active Members. In such a case the unspent proportion of Members' annual pre-payments will be returned.
